# WORK PROGRAMME 2019 FOR THE EUROPEAN STATISTICAL PROGRAMME 2013-2020

#### 1. Introduction

On the basis of the objectives given in Regulation (EU) 99/2013 of the European Parliament and of the Council of 15 January 2013 on the European statistical programme 2013-17, as extended to 2020 by Regulation (EU) 2017/1951 of the European Parliament and of the Council of 25 October 2017, this work programme contains the actions to be financed and the budget breakdown for year 2019 as follows:

- for grants (implemented under direct management) (point 2);
- for procurement (implemented under direct management) (point 3);
- for other actions (point 4).

#### Objectives pursued:

 Sustainability and further development of knowledge and expertise in seasonal adjustment and time series ensured and made available to the ESS members. Support to the development of methodologies for seasonal adjustment and temporal disaggregation at ESS level.

2.9. Action 9 — Direct grants to the United Nations (UN) in the area of partnership within the ESS and beyond (PA14)

Type of applicants targeted by the direct award:

In accordance with Article 195(f) of Regulation (EU, Euratom) 2018/1046: the United Nations.

The 4th edition of the Handbook of Statistical Organization (published by the UN for the first time in 1954) is a document with a global reach. It will contain comments on: (i) the strategic development areas generated by consultations with chief statisticians and senior managers of statistical organisations on the strategic development areas proposed in the Cape Town Global Action Plan for Sustainable Development Data; and (ii) the main outcomes of the series of conferences on a transformative agenda for official statistics. As the apex of the global statistical system, the UN is the only organisation at measure to lead this global work and to organise the transfer of knowledge in the UNCEEA (UN Committee of Experts on Environmental-Economic Accounting) through its regional outreach. This it will achieve by organising a dedicated conference.

Description of the activity to be funded by the grants awarded without a call for proposals on the basis of Article 195(f) of the Financial Regulation:

The action will cover the following topic:

Broader promotion of official statistics; high-level discussions on the most pressing
problems affecting the production, dissemination and use of official statistics;
exchange of knowledge, experience and best practices; development of countries'
statistical capacity and their national statistical systems.

The direct grant will take the form of a lump-sum contribution.

2.10. Action 10 — Direct grant to the Organisation for Economic Co-operation and Development (OECD) in the area of partnership within the ESS and beyond (PA 14)

Type of applications targeted by the direct award:

In accordance with Article 195(f) of Regulation (EU, Euratom) 2018/1046: the OECD, which has the sole technical competence in the field of the grant.

The OECD acts as the secretariat for the Cape Town Action Plan for Sustainable Development Data and coordinates actions relating to the plan.

Description of the activity to be funded by the grants awarded without a call for proposals on the basis of Article 195(f) of the Financial Regulation:

The action will cover the following topic:

• OECD/Paris 21 (Partnership in Statistics for Development in the 21st Century), a partnership to develop countries' statistical capacity and their national statistical

systems.

# 3.1. Procurements under the European Statistical Programme

General description of the contracts envisaged:

- Provision of statistical data collection, surveys, studies, analyses, reports, publications, updated manuals, methodology, documentation handbooks, other types of support, validation of data, indicators and benchmarks; improvement/development/modernisation of their processing; their analysis and improvement of their quality and the quality of statistics; development of new, modular techniques; maintenance and development of statistical infrastructure and databases;
- Implementation of a quality review of statistical production and processes;
- Processing, dissemination, promotion and marketing of statistical information;
- Development, maintenance, security and re-engineering of IT systems and infrastructure;
- Statistical data and metadata exchange support and corrective/evolutionary maintenance;
- Development of regular and secure data exchange channels between ESS members; increased knowledge on EU standards and ESS values, and increased awareness of issues of strategic importance for the ESS in the EECCA (Eastern European, Caucasus and Central Asia) countries;
- Risk-based control work at the sites of entities involved in producing statistical information in Member States;
- Purchase of services from external experts, as well as documentation, data and access for Commission departments to outside databases;
- Statistical training courses for statisticians, also for national statisticians and in third countries; support/organise exchanges of officials and information meetings;
- Subscriptions to international statistical associations and IT licences;
- Support for collaborative networks and organisations to back the implementation of the European Statistics Code of Practice and the new methods of production of European statistics:
- Provision of the information necessary to draw up an annual summary report on the economic and social state of the EU;
- Services in connection with the adjustment of the remuneration of officials and other staff;

- Technical assistance to national statistical institutes in Member States to increase their capacity to produce high-quality data;
- Provision of the necessary statistical information, at the request of the Commission or of the other institutions of the Union, for the assessment, monitoring and evaluation of the Union's expenditure.

#### New framework contracts:

(1) Under PA11 — multipurpose statistics and efficiency gains in production: framework contracts for 'IT for statistical production and for standardisation':

The framework contracts will enable support and maintenance of information systems for statistical production as well as standards for data and metadata exchange.

Duration of the framework contracts: 4 years.

(2) Under PA12 — dissemination and communication: framework contract for the purchase of external data:

Eurostat will make purchases of external statistical data within the European Commission more cost-effective by preparing and negotiating, for each statistical product, a framework contract of purchase for the whole Commission.
